Note:- I.All files pertaining to the following shall be submitted through Secretary, CVC by concerned Additional Secretaries:-

- I. All matters/complaints/cases pertaining to officers of All India Services viz IAS, IPS, JFS and officers of Group 'A' Services of and above grade pay of Rs. 10,000/- [Level-14 as per 7th CPC].
- II. All files pertaining to Board level officers and officers one level below Board level of Banks (including all CGMs/GMs)/Financial Institutions/Insurance Companies, PSUs/Authorities/Boards/Autonomous Bodies etc.
- III. All matters pertaining to prosecution sanction irrespective of the level of the Officer.
- IV. All legal files involving policy related issues.

2. All other files, unless otherwise directed by the Commission/Secretary, may be put up directly by the respective Additional Secretaries to the Commission.

3.All files pertaining to CTEO related work shall be put up through Secretary by concerned CTEs.

4 Administration files as per delegation of powers shall be put up by the Concerned Branch officer to Secretary through AS (Admin).

5.All files of Coordination Division, Confidential Section, IT Division, Media Activities, Systematic Improvement Committee and CVO of the Commission shall be submitted through Secretary, CVC.
